Some of the features are offices uniform in size, furniture and equipment; lots of natural light; state of the art technology throughout, an office booking software that allows individuals to reserve an office or a conference room from an app on their smart-phone; a room for nursing mothers, a meditation room and a wellness room. There is also beautifully detailed residential feel gathering spaces for relaxation and collaboration which includes a fireplace.

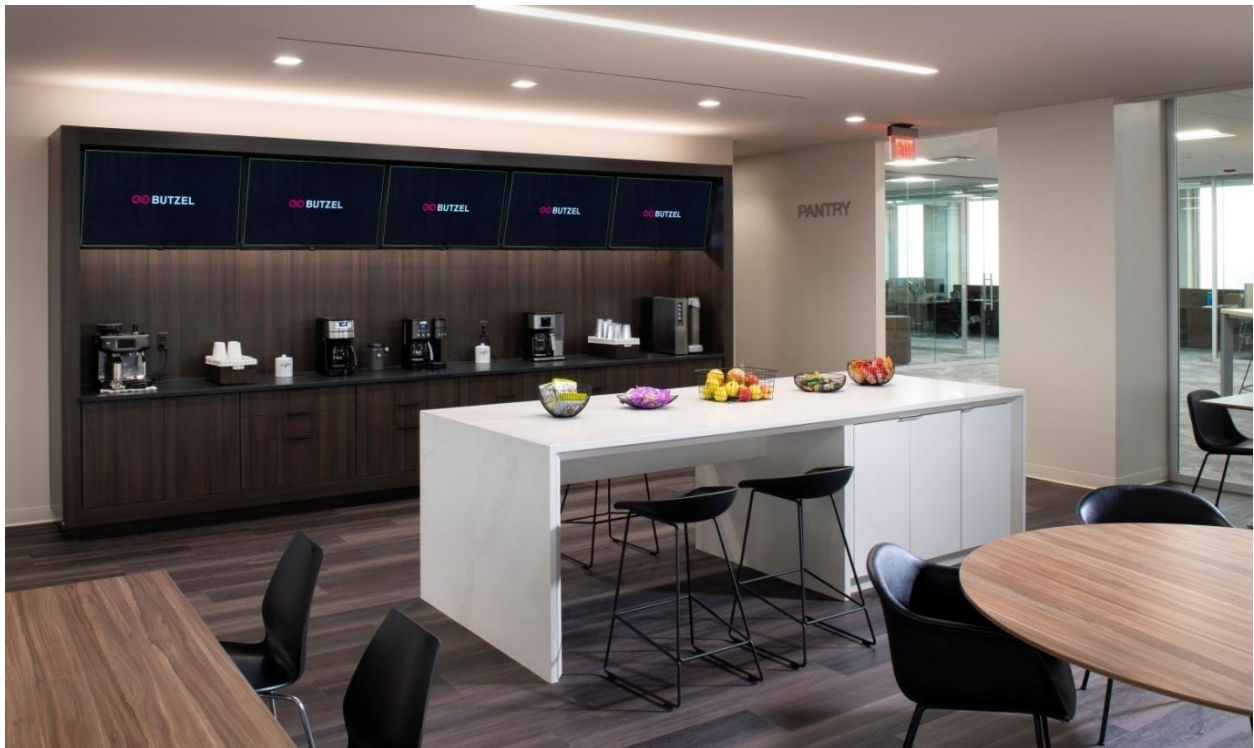
